- Vanilla, a member of the orchid family is a climbing monocot possessing a stout, succulent stem; short petiole, oblong leaves.
- The inflorescence is a raceme with 20 or more flowers. Flowers are 6 cm long, 2.5 cm wide, either yellowish green or white. Fruit probably known as 'beans' or 'pod' is a capsule, nearly cylindrical and about 14 cm long.
- Product is organically produced and processed according to current Good Manufacturing Practices, HACCP norms and regulations NOP & EEC 834/2007.
